Re: **Natural Gas Exchange Inc. - Notification and self-certification of product changes**

1. **SUBMISSION**

In accordance with Regulation 40.2, Natural Gas Exchange Inc. ("NGX") hereby submits amendments to the product schedule of its rulebook (the Contracting Party's Agreement or "CPA").

2. **RULE CHANGE**

NGX has amended Schedule "D" of the CPA to reflect that it will add several U.S. natural gas products for clearing. These additions are made in response to client requests and further expand our physical clearing offering in the U.S. The new additions will operate like all of NGX's Interstate pooling points and will require no additional procedures. The text of the Schedule "D" product schedule amendment is attached as Appendix "A", with revisions highlighted in blue.

3. **DATE OF IMPLEMENTATION**

The amendments will become effective as of October 10, 2011. NGX participants are being advised of today's submission to the Commission via the posting of a news item on the NGX website (www.ngx.com) concurrent with this submission. 4. **OPPOSING VIEWS**



1. **SUBMISSION**

In accordance with Regulation 40.6, Natural Gas Exchange Inc. ("NGX") hereby submits amendments to certain schedules of its rulebook (the Contracting Party's Agreement or "CPA").

2. **RULE CHANGE**

NGX is increasing its clearing fees for crude oil at U.S. delivery points. The U.S. fee increase reflects a market-based rate that should cover all incidental expenses NGX will incur for the process of physical and financial clearing. The text of the amendment is attached as Appendix "A", with additions underlined and deletions struck out.

An additional definition has been added to Appendix 2 to Schedule "H" of the CPA. The text of the Schedule "H" amendment is attached as Appendix "B" with additions underlined and deletions struck out.
