### **NGX AB-NIT Same Day Index**

There will be a change for the Weekend# number used as a proxy for the NGX Daily Spot Gas Price at “NGX AB-NIT Same Day Index”, published in the CGPR. The Weekend# will be established using all trades in the NGX “F6-Dec 21 (21, 22, 23, 24, 25, 26)” instrument traded on Friday December 21<sup>st</sup>, 2007.

For the 4 & 4A Indices the Weekend# will be used as a proxy for Dec 22, 23, 24, 25, and 26.

For the 5 & 5A Indices the Weekend# will be used as a proxy for Dec 21, 22, 23, 24, 25 and 26.

The WKD number will be established using the trading in the “SA5-Dec 22 (22, 23, 24, 25, 26)” instrument traded on Friday December 21<sup>st</sup>, 2007 at each of the Next Day hubs.

### **Revised NGX Spectra Station #2 Day Ahead Index**

The “**M2-Dec 31**” traded on Monday December 31<sup>st</sup>, 2007 will be used as a proxy for Dec 31<sup>st</sup> and January 1<sup>st</sup> at each of the respective hubs.

### Revised Spot Day Price Indices at Next Day Hubs

There Will be a change for the WKD number used as a proxy for each of the **NGX AB-NIT Day Ahead Index, NGX Union-Dawn Day Ahead Index, NGX Spectra Station #2 Day Ahead Index, and NGX AB-NIT/TCPL-Empress Transport Day Ahead Index** tables, published on Pages 15 and 16 of the Canadian Gas Price Reporter.
